

## Verifying Organisations for non-members – Route 2 option

Professional Association (PA) membership is encouraged in addition to CNHC registration because PAs play a crucial role in providing a range of services to their members.

If you are not a member of a relevant PA there are a number of organisations (listed below) who have agreed to verify applications for CNHC registration for non members. This means the organisation will assess your application for an administration fee but you do not have to join their organisation as a member.
