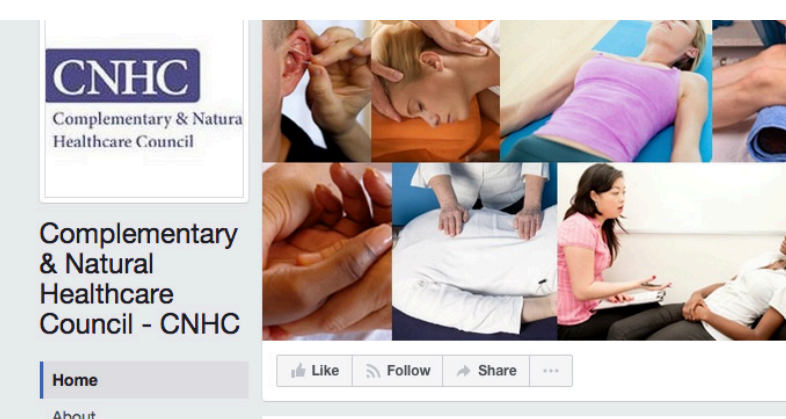

The CNHC Board met on Wednesday 25 April and approved several important documents including the 2017 Annual Report and Financial Statements, which will be available on the website as soon as the Financial Statements have been published by Companies House.

Private Health Cash Plans

We regularly receive questions about private health cash plans and which ones recognise CNHC registration. We have recently updated our information about private health cash plan providers who recognise CNHC registration for corporate and personal plans for a range of CNHC registered disciplines. These providers are Medicash, The Health Insurance Group, Pure Benefits, Westfield Health, Health Shield, Elect, Simplyhealth, Benenden, BHSF, UK Healthcare and Paycare.

Of course, it is essential that clients check their cover before committing to or paying for treatments if they want to apply for reimbursement of fees.

Random Sampling 2018

As part of our duty as a voluntary regulator, CNHC carries out a random sampling on an annual basis to check insurance certificates and CPD logs of registrants. This involves CNHC asking 5% of registrants to send us copies of their insurance certificate and CPD log for their last full year of registration. This year's sampling will begin on **Tuesday 8th May 2018** and the deadline to return documents will be Tuesday 5th June 2018.

If you are selected, you will be contacted by email and post to send us your completed CPD log and insurance certificate. If you need to update your contact details, you can do so by logging into [MyCNHC](#). **Please note that you are not required to send these documents unless you have been notified that you were selected as part of the random sample.**

Using the CNHC Quality Mark



If you are a CNHC registered practitioner, you are only permitted to include the CNHC Quality Mark for the discipline / disciplines you are registered for. The CNHC Quality Mark can be used on your website and publicity materials, but please note that use of the CNHC Quality Mark in relation to any disciplines not on our register is a breach of the regulations governing its use.
