Lifting of COVID-19 restrictions in the UK

ENGLAND

On Monday 19 July 2021 England moved to Step 4 of the UK Government's Roadmap out of lockdown. The UK Government have published new guidance for close contact services.

CNHC emailed Registrants on 19 July with advice on working safely, based on the new government guidance. We have now expanded and updated that advice which you can find here.

NORTHERN IRELAND

Since 26 July close contact services can operate without appointments and have overlapping appointments. You must collect client details to help with the Test, Trace, Protect contact tracing programme.

SCOTLAND

Scotland is currently at Level 0 which means that from 19 July you must maintain a minimum of 1m from clients and where this is not possible face masks continue to be a mandatory measure.

Scotland is due to move to 'Beyond Level 0' on 9 August if conditions allow. Find out more here.

WALES

On 17 July Wales entered Alert Level 1 which means it is still mandatory to wear face masks and maintain existing social distancing measures.

Wales is due to move to Level 0 on 7 August if conditions allow. Find out more here.

News from the Information Commissioner's Office

The Information Commissioner's Office (ICO), which is the UK's independent regulator for data protection and information rights, are engaging with organisations in the human health and therapy sector to help them comply with their legal obligations.

They will soon be writing to limited companies in the human health and therapy sector to remind them that they may have a legal responsibility to register with the ICO and pay the data protection fee. Therapists and practitioners who run their own business but aren't limited companies may not receive one of these letters but may also need to be registered with them.

CNHC Registrants are advised to check their legal responsibilities regarding data protection.
